DANCE ETIQUETTE & POLICIES

DANCE ETIQUETTE:

- 1) PLEASE COME PREPARED TO CLASS WITH A POSITIVE ATTITUDE, PROPER DANCE ATTIRE AND ARRIVE EARLY TO STRETCH AND WARM-UP.
- 2) PLEASE ARRIVE QUIETLY AND SPEAK SOFTLY IN THE LOBBY AREA.
- 3) PLACE YOUR BELONGINGS IN A CUBBY SO THE STUDIO REMAINS TIDY.
- 4) DANCE CLASS IS A TIME TO LEARN. PLEASE RESPECT YOUR TEACHER AND DEVOTE YOUR ATTENTION TO WHAT YOU ARE LEARNING. PRACTICE, LISTEN AND ATTEMPT TO APPLY ALL CORRECTIONS.
- 5) DRESS CODE: BALLET I-IV BLACK LEOTARD AND PINK TIGHTS WITH PINK SHOES. ALL CLASSES REQUIRE LEOTARDS, TIGHTS AND REQUIRED DANCE SHOES. "DRESS LIKE AND DANCER AND LOOK AND FEEL LIKE A DANCER." LEOTARDS & TIGHTS HELP YOUR INSTRUCTOR TO SEE ALIGNMENT AND MAKE PROPER CORRECTIONS. DANCE ATTIRE MAY BE PURCHASED DIRECTLY FROM IAD. STREET CLOTHING AND EXTRA T-SHIRTS, ETC. IS NOT PERMITTED. DANCERS NOT DRESSED TO DANCE MAY BE ASKED TO OBSERVE.
- 6) FOR ALL LADIES IN BALLET I-IV, PLEASE SECURE YOUR HAIR IN A NEAT BUN THAT WILL STAY SECURE THROUGH THE ENTIRE CLASS. ASK IF YOU NEED ASSISTANCE. OTHER CLASSES, PLEASE PULL YOUR HAIR BACK NEATLY.
- 7) PLEASE REMOVE ALL SHOES EXCEPT DANCE SHOES ON THE DANCE FLOOR. GUM CHEWING, SMOKING & FOOD/DRINK (OTHER THAN WATER) ARE NOT PERMITTED.
- 8) PLEASE DO NOT TOUCH THE MIRRORS OR HANG ON THE BARRES.
- 9) PLEASE DO NOT HAVE YOUR CHILD ATTEND CLASS IF THEY ARE SICK AND MAY BE CONTAGIOUS.
- 10) IF YOUR CHILD HAS AN INJURY, PLEASE ENCOURAGE THEM TO ATTEND CLASS AND WATCH, TAKE NOTES AND CONTINUE TO LEARN.
- 11) PLEASE CALL IF YOUR CHILD WILL BE ABSENT OR LATE.
- 12) ALL CHILDREN UNDER THE AGE OF 7 MUST BE ACCOMPANIED BY AN ADULT TO AND FROM THE DOOR FOR ALL CLASSES.
- 13) STUDENTS ARRIVING TO CLASS MORE THAN 10 MINUTES LATE MAY BE ASKED TO WATCH FOR SAFETY AND INJURY PREVENTION.
- 14) PHOTOS OF IAD CLASSES, PRODUCTIONS, REHEARSALS AND RELATED ACTIVITIES ARE THE PROPERTY OF IAD AND MAY BE USED FOR ADVERTISING & PUBLICITY.

TUITION POLICIES:

- 1) \$45 REGISTRATION FEE IS DUE IN SEP. FOR ALL CHILDREN'S CLASSES SEP-JUNE AND IS PAYABLE WITH OR BEFORE 1ST MONTH'S TUITION. PAID REGISTRATION RESERVES YOUR PLACE IN CLASS(ES). HOWEVER, IF TUITION IS NOT RECEIVED ON OR BEFORE THE DUE DATE, WAITING LIST APPLICANTS MAY BE CALLED TO FILL THE SLOT. REGISTRATION AND TUITION ARE NON-REFUNDABLE AND NOT APPLICABLE TO FUTURE MONTH'S/YEARS.
- 2) **TUITION** IS DUE ON THE 20TH OF THE PRIOR MONTH FOR WHICH IT IS DUE. A \$10 LATE FEE WILL BE ASSESSED TO EACH ACCOUNT AFTER THE 5TH OF THE MONTH. A \$15 FEE WILL BE ASSESSED FOR ALL RETURNED CHECKS. INVOICES WILL NOT BE RECEIVED UNLESS TUITION IS LATE. FULL TUITION IS BILLED SEP.-JUNE AND IS THE SAME REGARDLESS OF HOLIDAYS, SICKNESS, PERFORMANCE DATES, ETC. NO REFUNDS, CREDITS OR MAKE-UPS WILL BE GIVEN UNLESS THE CLASS IS CANCELLED BY THE IAD OR WITH PRIOR APPROVAL. EACH STUDENT'S ACCOUNT WILL BE CHARGED THE FULL MONTH'S TUITION SEP.-JUNE, UNLESS A DROP FORM (AVAILABLE ON REQUEST) IS RECEIVED BEFORE TUITION IS DUE. TUITION OR PAYMENT MORE THAN 60 DAYS OVERDUE, EXCESSIVE ABSENCE OR TARDINESS MAY BE GROUNDS FOR DISMISSAL FROM DANCE CLASS. REFUNDS WILL NOT BE ISSUED AND PAST DUE TUITION WILL BE COLLECTED.
